**VERIFIED COMPLAINT TO INSTITUTE PROCEEDINGS TO PREVENT
CRIME PURSUANT TO MCL 772.1, ET SEQ**

Now comes the Wayne County Prosecutor, Kym L. Worthy, by and through her Assistant Prosecutors, Donn Fresard, and Robert Moran, and in support of this Petition, states as follows:

1. Petitioner is the Chief Law Enforcement Officer for the County of Wayne, State of Michigan and has standing to pursue this action.

49.153 Prosecuting attorney; duties.

Sec. 53.

The prosecuting attorneys shall, in their respective counties, appear for the state or county, and prosecute or defend in all the courts of the county, all prosecutions, suits, applications and motions whether civil or criminal, in which the state or county may be a party or interested.

2. Defendants have embarked on a threatened course of conduct designed to breach the peace within the city limits of Dearborn, Wayne County, Michigan, to wit the incitement of a riot contrary to MCL 752.542:

752.542 Inciting to riot.

Sec. 2.

It is unlawful and constitutes incitement to riot for a person or persons, intending to cause or to aid or abet the institution or maintenance of a riot, to do an act or engage in conduct that urges other persons to commit acts of unlawful force or violence, or the unlawful burning or destroying of property, or the unlawful interference with a police officer, peace officer, fireman or a member of the Michigan national guard or any unit of the armed services officially assigned to riot duty in the lawful performance of his duty.

3. Petitioner submits that the planned and proposed actions of the confederates, as detailed below, justifies the initiation of these proceedings pursuant to MCL 722.1, and that this Court has exclusive jurisdiction over this matter:

722.1 Power of district or municipal judge to cause laws for preservation of public peace to be kept; requiring security to keep peace.

Sec. 1.

A district or municipal judge may cause all the laws made for the preservation of the public peace to be kept and, in the execution of this authority, may require a person to give

security to keep the peace in the manner provided in this chapter.

4. This pleading is the written complaint or oath required by the Statute:

772.2 Complaint; examination of complainant and witnesses.

Sec. 2.

If a complaint is made in writing and on oath to the district court or a municipal court that a person has threatened to commit an offense against the person or property of another, the judge shall examine on oath the complainant and any witnesses who may be produced.

5. Additionally, the common-law definitions of that behavior which would constitute a “breach of the peace,” have been discussed in several cases involving the applicability and constitutionality of proceedings under this section, including the *Bellock* case, which arose in a Wayne County jurisdiction.

“ A “breach of the peace” has been defined in Michigan as any intentional violation of the natural right of all persons in a political society to the tranquility enjoyed by citizens of a community where good order reigns among its members.

We hold therefore that the peace bond statute is not constitutionally infirm. Consequently, we conclude that the peace bond statute provides a person of ordinary intelligence a reasonable opportunity to know what is prohibited. Applying this common law to the statute at issue, we further construe the peace bond statute to apply to offenses against the person or property of another that involve some threat of personal violence. ⁵” [*Dearborn Heights v. Bellock*, 17 Mich.App. 163, 168, 169 N.W.2d 347 (1969).]

Factual Assertions in Support of Complaint

6. Pastor Terry JONES became an internationally known figure in September, 2010 as he publicly sought to burn a copy of the “Koran”, the Muslim holy book, on September 11, 2010 on the ten year anniversary of the terrorism attack on the U. S.

7. As a result of the international publicity surrounding this event Pastor JONES actions created International safety concerns to Americans traveling abroad and American military troops serving in foreign countries. Only after direct

8. intervention from President Obama's administration did Pastor JONES decide not to carry out his planned Koran burning.
8. On March 20, 2011, Pastor JONES and the Dove Outreach Center conducted an "International Judge the Koran Day" which was broadcast live via the internet and has been posted on public sites including You Tube.
9. Pastor Jones served as the judge in this trial and ultimately found the Koran "guilty of training and promoting of terrorist activities around the world, the death, rape, and torture of non-Muslims, crimes against women, minorities, Christians, and promoting prejudice and racism against non-Muslims".
10. Upon rendering the verdict a copy of the Koran was immediately burned. The actual individual that burned the Koran was Wayne SAPP and SAPP noted as the On-site Coordinator on the City of Dearborn Special Events Application and Request form.
11. Earlier this year, Frank FIORELLO and his organization "Order Of The Dragon, O.O.T.D.) forwarded a Special Events Application and Request form to Dearborn Police Department Special Events Unit requesting a permit to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan.
12. The Islamic Center of America is the largest Mosque in North America. The stated purpose of this event was to protest "Sharia law and Jihad".
13. At that time FIORELLO stated a keynote speaker was going to be Pastor JONES.
14. Upon submission of the Special Events permit the "Stand Up America Now" website began generating mass international media attention to the event.
15. Subsequent contact with FIORELLO facilitated the providing him with a copy the City of Dearborn Ord. No. 08-1182 which outlined the financial and legal responsibilities of the permit holder.
16. FIORELLO subsequently rescinded his permit application .
17. FIORELLO expressed that as a consequence of life tragedies, the generated media attention, and large number of physical threats to personal safety to demonstration attendees as well as Americans around the world resulting from Pastor JONES'S organizations previous actions and international marketing campaign of this event has convinced him that separation from Pastor JONES and this event was in his organizations best interest

18. On April 9, 2011, "Stand Up America Now", submitted City of Dearborn Special Events Application and Request Form. The permit requests to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan between the hours of 5:00pm and 8:00pm.
19. The Islamic Center of America is the largest Mosque in North America. The permit listed the name of the event as, "Stand Up America Now: Protest Shari'a and Jihad" and describes the event as a "Peaceful Demonstration".
20. The permit application lists the contact person as Stephanie SAPP of Gainesville, Florida and the On-Site Coordinator as Wayne SAPP.
21. Special Events staff from the Dearborn Police Department has been in contact with the listed event contact person, Stephanie SAPP, and has also had direct contact with Pastor JONES.
22. Contact with Stephanie SAPP and Pastor JONES facilitated the providing them with a copy of the City of Dearborn Ord. No. 08-1182 which outlined the financial and legal responsibilities of the permit holder.
23. Stephanie SAPP revealed that Pastor JONES is receiving large numbers of threats against his life and subsequently was requested to forward threats to Dearborn Police Special Events staff.
24. An intensive intelligence initiative conducted by the Dearborn Police Department has confirmed International condemnation and protests of JONES' activities may have spurred a violent attack in Afghanistan and promoted a designated foreign terrorist organization to call for JONES' death.
25. The Department continues to receive reports that opportunists may be trying to incite individuals to further violence.
26. As of 13 April, public condemnation of the Koran burning, including by senior officials from Pakistan and Afghanistan, spurred violent protests in Afghanistan during which 20 people were killed, including seven United Nations employees.
27. Leaders of Jamaat-ud Daw'a, a cover organization for Pakistan-based terrorist group Lashkar-e-Tayyiba, publicly announced a \$1.17 million reward for JONES' assassination, according to Indian and Pakistani press.
28. Some users of publicly available social media Web sites

and sites promoting violent extremist view of “Jihad” have similarly called for JONES’ assassination.

29. The Islamic Center of America is located in a religious worship area known as “Altar Rd.” The Islamic Center of America is neighbor to six other churches in this geographic area which are of various Christian Denominations.

30. This area also hosts two grade schools, one of which is associated with the Islamic Center. A high rise retirement building associated with one of the is also located in this district. All of the religious institutions have their own private parking areas and share a common entrance road (Altar Rd.) which is accessed from Ford Rd. (M-153) which is a six lane divided highway. There is no available public parking in this area. The only public area available for demonstration in the area is a grass bermed area separating Ford Road from Altar Rd. with approximate dimensions of 200yds x 15yds.

31. It is important to note that April 22, 2011 is the Christian holiday “Good Friday” which is of monumental importance in all Christian Religions marking the crucifixion of Jesus Christ. All of the Christian churches located in the Altar Rd. district have planned religious events throughout the day to recognize the significance of this religious event. As a result of these planned religious events, population and vehicular traffic to this area is expected to be extremely high.

32. “Stand Up America Now” in their Special Events Application state that their expected event attendance is “2” even though they have marketed this event on their Website.

33. “Stand Up America Now” has identified Pastor Terry JONES and Wayne SAPP as being the attendees for this demonstration.

34. They have also stated that both JONES and SAPP believe in the right to openly carry a firearm and have stated both will be doing so in adherence to the guidelines of Michigan law.

35. “Stand Up America Now” has also indicated several other followers will be coming with JONES and the SAPPs.

36. In communications with ‘Stand Up America Now’ contact person Stephanie SAPP it has been relayed to Dearborn Police Special Events staff that Pastor JONES has received over 300 internet death threats since publicly announcing his attendance to the demonstration in front of the Islamic Center of America in Dearborn, Michigan.

37. Upon request Stephanie SAPP has forwarded these threats to the Dearborn Police Department via e-mail.
38. Cpl. Danak of the Dearborn Police Department has maintained communications with both Stephanie SAPP and Pastor JONES. On April 3, 2011, Cpl. Danak provided SAPP with a copy of the City of Dearborn Ord. No. 08-1182 which outlined the financial and legal responsibilities of the permit holder, a Special Events Application and Request Form and thoroughly explained to Stephanie SAPP the availability of four designated, "Free Speech Zones" established by the City of Dearborn to accommodate peaceful demonstrations in which groups would be free from event costs and permit requirements.
39. On April 8, 2011 Cpl. Danak discussed at great length with Stephanie SAPP the logistical issues with their desired demonstration location explaining logistical difficulties regarding parking, traffic, and the ability to physically accommodate the potential turn out of predictable high volumes of demonstrators and counter-demonstrators generated by the worldwide attention focused on this event through the internet and the media.
40. Cpl. Danak also explained the serious concerns to public safety and the protection of Pastor JONES' in light of the numerous physical threats and bounties to Pastor JONES.
41. Stephanie SAPP's response to these issues was that they were confident in their Christian faith and believe Jesus Christ will keep JONES and the other demonstrators safe. Cpl. Danak explained to Stephanie SAPP that due to logistical and public safety issues that there is a possibility that the requested Special Events permit may be denied.
42. Stephanie SAPP replied whether there is a permit or not, Pastor JONES and other demonstrators will be **at that location** demonstrating regardless of the legal ramifications.
43. Attached are both application of the Reverend Jones Organization, as well as the application of the "Stop the Hate" Rally, estimating 500 to 1,000 people to appear "in front of the Islamic Center" because of "Pastor Jones' Visit."
44. The Initial danger is the blocking of a two lane street in an area deemed to be unsafe for a gathering.
45. The greatest danger is the likelihood of a riot ensuing, complete with the discharge of firearms, unless this proposed bond is granted.

For these reasons, and also relying on the exhibits attached hereto, the People respectfully request that this Court find the threshold of **MCL 722.2** has been met and issue its

Order(s) Compelling the named Defendants to appear before the Court at a date and time within 7 days.

AFFIDAVIT OF RONALD HADDAD

RONALD HADDAD, being first duly sworn, testifies as follows:

1. I have personal knowledge of the facts in this affidavit, and if called as a witness, can testify competently to the facts.
2. I have 37 years of experience in law enforcement.
3. I am currently the chief of police for the City of Dearborn, and have served in that position since December of 2008.
4. Prior to being appointed to the position of chief of police for the City of Dearborn, I served for 34 years as a police officer for the City of Detroit.
5. For approximately six years, I was in charge of Homeland Security for the City of Detroit.
6. I have been sworn to support the Constitution of the United States and the Constitution of the State of Michigan; as Chief of Police, my mission is to provide a sense of security for the people by protecting life and property, reducing the opportunity for crime and disorder, enforcing the law, and providing other police-related services as required by the community in a manner consistent with the values of a free society.

7. On April 8, 2011, the Dearborn Police Department received a Special Events Permit Application submitted by an organization known as "Stand Up America Now". I received information that "Stand Up America Now" is an internet-based organization associated with Pastor Terry Jones and his church organization known as

the Dove World Outreach Center. Pastor Jones became an internationally known figure when he publicly sought to burn a copy of the "Koran", the Muslim holy book, on September 11, 2010, the nine year anniversary of the terrorist attacks on the United States. I have learned that, as a result of the international publicity surrounding this event, Pastor Jones' actions created International safety concerns to Americans and American troops serving in foreign countries. Only after direct intervention from President Obama's administration did Pastor Jones decide not to carry out his planned Koran burning.

7. In the April 8, 2011, Special Events Application that was submitted to the Dearborn Police Department, "Stand Up America Now" requests a permit to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan between the hours of 5:00pm and 8:00pm, on April 22, 2011 The permit lists the name of the event as, "Stand Up America Now: Protest Sharia and Jihad."

8. I have learned that, on March 20, 2011, Pastor Jones conducted an "International Judge the Koran Day", which was broadcast live via the internet and has been posted on public sites including YouTube. Pastor Jones served as the judge in this trial and ultimately found the Koran "guilty of training and promoting of terrorist activities around the world, the death, rape, and torture of non-Muslims, crimes against women, minorities, Christians, and promoting prejudice and racism against non-Muslims". Upon rendering the verdict, a copy of the Koran was immediately burned. The actual individual that burned the Koran was Wayne Sapp. Mr. Sapp is identified as the On-site Coordinator on the City of Dearborn Special Events Application submitted to the Dearborn Police Department by "Stand Up America Now."


9. On April 8, 2011, in the interest of due diligence and public safety regarding this event, I authorized an intensive intelligence initiative. On April 13, 2011, I received a "Joint Intelligence Bulletin" issued by the Federal Bureau of Investigation and the Department of Homeland Security. **This bulletin is "law enforcement sensitive."** This bulletin is titled "Florida Koran Burning Gaining Attention and Eliciting Responses Worldwide." According to the bulletin, its is to "assist federal, state, local, and tribal government agencies and authorities to develop priorities for protective and support measures relating to an existing or emerging threat to Homeland security". A section of this bulletin titled, "Worldwide Response to Koran Burning", states, "International condemnation and protests of Jones' activities may have spurred a violent attack in Afghanistan and promoted a designated foreign terrorist organization to call for Jones' death; we continue to receive reports that opportunists may be trying to incite individuals to further violence. We assess with medium confidence that the international outcry over the recent Koran burning in Florida will continue, leading to more protests, additional media attention, and copycat incidents that could prompt additional violence. **As of 13 April, public condemnation of the Koran burning, including by senior officials from Pakistan and Afghanistan, spurred violent protests in Afghanistan during which 20 people were killed, including seven United Nations employees.** Leaders of Jamaat-ud Dawa, a cover organization for Pakistan-based terrorist group Lashkar-e Tayyiba, publicly announced a \$1.17 million reward for Jones' assassination, according to Indian and Pakistani press. Some users of publicly available social media Web sites and sites promoting violent extremist view of "Jihad" have similarly called for Jones' assassination". It is also stated, "There have not been any violent responses to Jones' Koran burning in the United States thus

far; however the risk of violence could increase both at home and abroad as Jones' activities continue to gain attention. Additionally, we assess that violent extremist groups targeting the United States could leverage anger over Jones' activities to advance their recruitment efforts. Jones has publicly stated his intention to join an "Anti Sharia and Jihad Protest" in front of the Islamic Center of America in Dearborn, Michigan on 22 April 2011, and has indicated that he may put the prophet Mohammad on trial on an unspecified date". The bulletin also states violent extremists could use the Koran burning and these events and the perceived failure of the U.S. government to prevent these activities to recruit individuals to target the United States or Jones. "Calls for retaliation against U.S. interests may motivate individuals to take action against U.S. persons and entities within the United States and overseas".

10. I have also become aware that the International Media is reporting on worldwide events that have the potential to have profound effects to the safety and security of the City of Dearborn should Pastor Jones carry out the proposed demonstration. On April 1, 2011, Fox News reported "Seven killed Koran burning protest headquarters Afghanistan" stating seven people have been killed at a U.N. office in the Northern city of Mazar-i-Sarif when a Koran burning protest turned violent.

11. Based on the information learned through the intensive intelligence initiative, I believe that Paster Jones intends to engage in conduct that will put his safety and that of the public at risk. Intelligence received leads me to believe that Pastor Jones will jeopardize the safety of the public by committing an act against the person or property of another in the form of burning a Koran.

3. Currently, I am the sergeant assigned to the Special Events division of the Dearborn Police Department.
4. On April 8, 2011, the Special Events division of the Dearborn Police Department received a Special Events Permit Application submitted by an organization known as "Stand Up America Now". I received information that "Stand Up America Now" is an internet-based organization associated with Pastor Terry Jones and his church organization known as the Dove World Outreach Center. Pastor Jones became an internationally known figure when he publicly sought to burn a copy of the "Koran", the Muslim holy book, on September 11, 2010, the nine year anniversary of the terrorist attacks on the United States. I have learned that, as a result of the international publicity surrounding this event, Pastor Jones' actions created International safety concerns to Americans and American troops serving in foreign countries. Only after direct intervention from President Obama's administration did Pastor Jones decide not to carry out his planned Koran burning.

5. In the April 8, 2011, Special Events Application that was submitted to the Dearborn Police Department, "Stand Up America Now" requests a permit to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan between the hours of 5:00pm and 8:00pm, on April 22, 2011. 8. It is anticipated that, to accommodate Pastor Jones, the City of Dearborn will incur costs in the approximate amount of \$46,351.98.



DOUGLAS TOPOLSKI, being first duly sworn, testifies as follows:

1. I have personal knowledge of the facts in this affidavit, and if called as a witness, can testify competently to the facts.

2. I have been employed by the City of Dearborn as a police officer since June of 1989.

3. Currently, I am the sergeant assigned to the Traffic Safety and Accident Investigation Bureau of the Dearborn Police Department; I have held this position since May of 1999.

4. I became aware that a Special Events Application was submitted to the Dearborn Police Department, "Stand Up America Now" requests a permit to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan between the hours of 5:00pm and 8:00pm, on April 22, 2011.

5. The Islamic Center of America is located in a religious worship district known as "Altar Road." The Islamic Center of America is neighbor to six other churches in this geographic area which are of various Christian denominations. This area also hosts two grade schools (approximately 500 students), one of which is associated with the Islamic Center. A high rise retirement building associated with St. Sarkis, an Armenian Church, houses 151 senior residents and is also located in this district.

6. All of the religious institutions have their own private parking areas and share a common entrance road (Altar Road) which is accessed from Ford Road (M-153). Altar Road is a two-lane road with no turning lanes. Ford Road is a six-lane divided highway with a posted speed limit of 50mph. Individuals enter and exit Altar Road from the same singular access point off of Ford Road.

7. This area has been under study by the Dearborn Police Department and the Michigan Department of Transportation (MDOT) for over a year because of the recognized traffic flow issue. Due to the significance of the various safety concerns, funding has been approved for a major roadway reconfiguration. Because of heavy traffic from the Mosque, the two schools located near the Mosque, the Armenian Community Center, and the other churches and apartments, it has become necessary to consider a total roadway redesign to improve safety.


8. The primary safety concern is centered around the congestion and traffic conflict that takes place around the Ford Road access point. Drivers attempting to access Ford Road from Altar Road, and Altar Road from Ford Road, cause a significant threat of potentially serious crashes between both vehicles and pedestrians.

9. Because of the current configuration, the use of Altar Road by the members of the various religious institutions on April 22, 2011, Good Friday, in conjunction with participants in Pastor Jones' proposed demonstration, will result in significant and potentially life-threatening traffic problems.

10. Additionally, there is no public parking in the area of Altar Road and Ford Road.

11. Further, the only "public" area at this location is a bermed section of grass that separates Ford Road from Altar with the approximate dimensions of 200 yds x 15 yds.

AFFIDAVIT OF ANDREA DANAK

ANDREA DANAK, being first duly sworn, testifies as follows:

1. I have personal knowledge of the facts in this affidavit, and if called as a witness, can testify competently to the facts.
2. I have been employed by the City of Dearborn as a police officer since July of 1999.
3. My current assignment is as a corporal with the Special Events Division of the Dearborn Police Department.
4. On April 8, 2011, I received a Special Events Permit Application submitted by an organization known as "Stand Up America Now"; the application was submitted by Stephanie Sapp. I have knowledge that that "Stand Up America Now" is an internet-based organization associated with Pastor Terry Jones and his church organization known as the Dove World Outreach Center. Pastor Jones became an internationally known figure when he publicly sought to burn a copy of the "Koran", the Muslim holy book, on September 11, 2010, the nine year anniversary of the terrorist attacks on the United States. I have learned that, as a result of the international publicity surrounding this event, Pastor Jones' actions created international safety concerns to Americans and American troops serving in foreign countries. Only after direct intervention from President Obama's administration did Pastor Jones decide not to carry out his planned Koran burning.

5. In the April 8, 2011, Special Events Application that was submitted to the Dearborn Police Department, "Stand Up America Now" requests a permit to conduct a demonstration in front the Islamic Center of America located at 19500 Ford Rd., City of Dearborn, County of Wayne, State of Michigan between the hours of 5:00pm and 8:00pm on April 22, 2011. The permit lists the name of the event as, "Stand Up America Now: Protest Sharia and Jihad."

6. On April 8, 2011, I had a telephone conversation with Stephanie Sapp regarding the Dearborn Special Events ordinance. I advised her of the logistic difficulties with conducting a demonstration in front of the Islamic Center and advised her that, because of these difficulties, the application may be denied. I also provided her with the locations of the "free speech zones" in Dearborn. In addition, I discussed with Ms. Sapp the attention that this event was getting and the Police Department's concern for public safety.


7. Ms. Sapp advised me that Pastor Jones would be coming to the Islamic Center on April 22, 2011 "even if the application was denied."

8. Ms. Sapp also stated that "they had a firm belief in Jesus Christ and he would protect them."

9. On April 11, 2011, Ms. Sapp contacted me and asked about Michigan's "open carry" law. Ms. Sapp indicated that Paster Jones would be accompanied by Wayne Sapp; both have valid CPLs and would be carrying their pistols.

10. At my request, Ms. Sapp has forwarded more than 40 email messages threatening the life of Pastor Jones.
