NARRATIVE

NARRATIVE:

On June 2, 2012 at 2:00 am uniformed Shawnee Hills Police Officer's Stacy S. Rainey, Badge #866, and Officer Laura T. Diamond, Badge #861, were on foot patrol in the area of The Oxford School during the Muirfield Memorial Golf Tournament.

Officers observed three males that appeared to be urinating on the Oxford school. Officers shined a flashlight on the males and they fled on foot. Officers identified themselves as police officers and the males continued to run. Chief Sean A. LeFever, Badge #857, of the Shawnee Hills Police Department joined the chase and activated a Shawnee Hills Police Cruiser's overhead red and blue emergency lights, identified himself as a police officer and ordered the males to stop, they continued to run.

Chief LeFever located and apprehended Jacob Stoneburner and Austin Barnard who were hiding behind a parked vehicle in a parking lot off of Dublin Road south of the shopping plaza. Mr. Stoneburner admitted that he was urinating just before he ran. Sergeant Russell C. Baron, Badge #862, apprehended the third male, Jack Mewhort after he emerged from a wooded area in which he had been hiding.

Chief LeFever did sustain a closed fracture to the base of his right thumb while chasing the three individuals. Concord Township Medic #341 initially treated Chief LeFever, and at their suggestion transported to the Dublin Methodist Hospital where it was confirmed his thumb was broken.

All three males were taken to a police substation for processing where they were read their constitutional rights and declined to answer interview questions. Sergeant Baron was assigned the investigate the incident and later charged Mr. Stoneburner with public urination and for obstructing official business. Sgt. Baron charged Mr. Mewhort and Mr. Barnard with obstructing official business and later slated all three males at the Delaware County Jail.

Officer Witness Summary

On June 2, 2012, I was on uniformed foot patrol with Officer Stacy Rainey (badge #866) in the Remax parking lot during the Memorial Tournament.

At approximately 02:00, we observed three white males on foot, cutting through the bushes between the Bogey parking lot and the Remax lot. They wandered through the parking lot and then ducked into the alley between the Oxford buildings (building 6065 and 6055).

Officer Rainey was approximately 15 feet in front of me walking towards the subjects. As she approached, Officer Rainey asked, "What are you doing?" At that point Officer Rainey ran into the alley, and yelled, "Police, stop!" It was then apparent to me that the subjects had fled. I pursued the subjects with Officer Rainey. We ran up the embankment westbound after three males. They continued running around the back of the Shawnee Square Stores. As I reached the top of the embankment, I witnessed the three males turn the corner behind the stores, and I marked on the Shawnee Hills PD radio channel requesting assistance with a description and direction of travel.

Chief LeFever (badge #857) was in a marked patrol vehicle and with his emergency lights as he passed us and took the lead of the pursuit at that time. I witnessed the three males run up the hill towards the woods on Dublin Rd. in a southbound direction. Chief LeFever marked on radio that he had a visual, and that they were running into the parking lot behind the woods.

I continued to follow on foot into parking lot 6 on Dublin Road; I witnessed two males in custody with Sgt. Bill Bartram (badge #853) and Sgt. Doug Devore (badge #855) behind a vehicle near the tree line. Chief LeFever was also in the area. He was holding his right hand and stated that he thought he broke his finger when he fell during his pursuit.

The subjects in custody were later identified as Jacob Stoneburner and Austin Barnard. The subjects were arguing with the officers about the reason they were running, stating, "we thought we were our girlfriends and we took off running in order to ditch them." When asked where the third suspect was, Mr. Stoneburner and Mr. Barnard stated they didn't know where he went. Sgt. Bartram asked them for the name of their friend. I didn't hear the answer, but was later told by Sgt. Bartram that the name given was not the subject's name. I recalled the third suspect was wearing a dark shirt, and I asked the suspects to describe their friend's clothing. Mr. Stoneburner stated that he was wearing a black shirt.

I heard a request for a K9 unit to be dispatched. At the same time Officer Fields (badge #868) and I escorted the two Mr. Stoneburner and Mr. Barnard to a police vehicle to be secured. Officer Fields conducted a search of each subject and they were secured in a marked police vehicle.

As we prepared to drive the subjects back to the sub, Chief LeFever walked up to us and told us that the third suspect came out of the woods when he heard that a K9 had been requested.

Officer Fields and I drove Mr. Stoneburner and Mr. Barnard back to the sub-station for processing. During the ride, I overheard one say to the other, "Yeah, I knew they were cops."

Once at the substation, videotape was turned on. All three subjects were brought in, the third one being identified as Jack Mewhort. I advised them of their Miranda rights and asked them if they understood them. They each stated that they understood. I then asked them if they wanted to waive those rights and answer our questions. Mr. Mewhort and Mr. Stoneburner immediately refused to waive their rights and advised Mr. Barnard to do the same. All three refused to answer any questions.

During processing Mr. Stoneburner and Mr. Mewhort complained of pain from their handcuffs and numbness in their hands. I adjusted Mr. Mewhort's handcuffs to ease his discomfort. Officer Rainey adjusted Mr. Stoneburner's handcuffs.

All three subjects were very polite and compliant, and asked if they could use the bathroom. After clearing it with Sgt. Baron, handcuffs were removed from all three subjects and were allowed to use the bathroom, and were given bottles of water.

After processing was completed, all three subjects were taken to Delaware County Jail by Sgt. Russell Baron and Sgt. Todd Ekleberry (badge #859) and were slated.

Officer Witness Summary

On June 2, 2012 at approximately 2:00 am, Officer Stacy S. Rainey, Badge #866, and Officer Laura T. Diamond, Badge #861, uniformed police officers, both of the Shawnee Hills Police Department (SHPD), Delaware County, OH, were on foot patrol in Remax parking lot for the Muirfield Memorial Tournament and observed three males acting suspiciously and appearing to be urinating on the side of The Oxford School (6065 Glick Road), which is a child care center. Both uniformed officers approached the males to investigate their activity.

After making visual contact with the officers, all three males began to run westbound behind the Shawnee Square shopping center with the officers running closely behind them yelling, "Police stop". Officer Diamond aired to all SHPD officers that they were in foot pursuit of the three males. Chief Sean A. LeFever, Badge #857, of the Shawnee Hills Police Department was driving a marked police vehicle and encountered the individuals as they were running up a hill to turn south on Dublin Road. Chief LeFever activated the marked police vehicle's overhead red and blue emergency lights and yelled, "Police stop". Chief LeFever took the lead in the foot pursuit of the three individuals announcing several times that he was a police officer.

Officers chased the three males south on Dublin Road to a parking lot area for the Memorial Tournament parking. Two of the suspects, later identified as Jacob Stoneburner and Austin Barnard, were apprehended approximately 100 feet off of Dublin Road in the parking lot by Chief LeFever and SHPD Sergeant Doug DeVore, Badge #855. Stoneburner and Barnard were up against a vehicle and were talking to officers. One of the suspects, later identified as Jack Mewhort, had fled into a dark wooded area between the shopping center and the parking lot. Officer Fields and I began looking through the wooded area for the third suspect. After being unable to locate the suspect, we returned to the other officers. Sergeant DeVore mention that the K-9 unit was in route and at that time the suspect emerged from the woods covered in mud. The suspect had his hands raised and was apologizing for running. Sergeant Baron placed him in handcuffs, patted him down, and he was then placed into a marked SHPD police vehicle.

The three suspects were transported to the Shawnee Hills Police Department sub-station for arrest processing. Officer Diamond mirandized the suspects, and verified with each that they understood their rights. Miranda, as well as the interviews and processing, were video taped.

During the foot pursuit, Chief LeFever slipped on mud and fell to the ground, injuring his right thumb. Concord Township Medic #341 treated Chief LeFever at the sub-station, advising that they believed it to be broken. SHPD Sergeant Bill Bartram, Badge #853, transported Chief LeFever to Dublin Methodist Hospital for treatment. Dublin Methodist Hospital confirmed that Chief LeFever did in fact break his right thumb.

All three males were slated at the Delaware County Jail for varying charges.
