### Call Short Narrative

While on patrol on NB IR 475, I observed a gold Chevy operating at what appeared to be a speed higher than the posted limit. The Chevy was weaving through traffic at a high rate of speed. I caught up to the Chevy at the 2 MM on NB IR 475 and paced the vehicle with the radar unit in car 6 on in the moving mode. I paced the vehicle at 95 MPH from the 2.4 MM to the 3 MM. I activated my overhead lights and the Chevy pulled over near the 3.8 MM. I approached the driver's side window and identified myself to the driver. I asked the driver, later identified as Talbot, if there was a reason why she was driving 30 MPH over the posted speed limit. Talbot advised that she had just dropped off her father and was anxious to get back home. I detected a strong odor of burnt marijuana coming from the vehicle. I asked Talbot if she had smoked any marijuana tonight. She advised that she had smoked some yesterday but not today. I did not observe any indications that Talbot was under the influence of marijuana. Talbot advised that I could search the car if I wanted to. I asked her to step out of the vehicle and to sit in the back seat of my patrol car due to the weather. Talbot complied and sat in my patrol car while I checked the passenger area of her vehicle. I located a plastic bag of marijuana in the center console of the vehicle. Ofc McGuffin arrived and confirmed that there was an odor of burnt marijuana. Aside from the plastic bag in the center console, no other controlled substances were located in the vehicle. I went back to my patrol car and advised Talbot of the drugs that were discovered. She advised that the marijuana belonged to her father. I told her that since she was operating the vehicle, she was in possession of the drugs. Talbot was cited for Speed (mm) and Drug Possession-Marijuana (mm).
