I was stationary on IR-75S at US 20 off ramp. I observed a brown Chevrolet Malibu OH-EYR4505 in the left lane on IR-75S near the 194.0 mile post. The vehicle appeared to be traveling faster than the posted speed limit of 65 mph. I estimated the vehicle speed to be 80 mph. I activated laser unit # UX014977 and it displayed a reading of 84 mph at 464.7 ft from the cruiser. 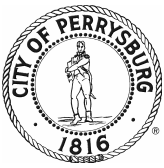

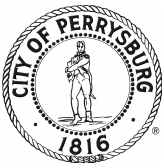

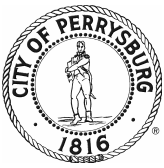
