### Call Short Narrative

While on patrol, I was stopped at a red light behind a vehicle on westbound Roachton Rd. east of SR-25 in the right hand lane. There were two other vehicles behind me at the time. I then observed a silver Honda start to go out around the second vehicle behind me to the left, toward the left turn lane but the Honda stopped. The silver Honda then turn on its right turn signal, and turned right into the parking lot of Exxon On the Run going between the car directly behind me and the vehicle two back. As I watched, the silver Honda drove straight through the parking lot and onto westbound Washington St. I drove around the vehicle in front of me and turned north onto SR-25 just as the silver Honda was turning north onto SR-25. I stopped the Honda Civic (IL-N321042) and identified the driver as Shyam Goverdhana. I then explained that I stopped him for shortcutting to avoid the red traffic signal. Next, I asked him why he had started to go into the left hand turn lane, and I asked him if he was trying to bypass the traffic already sitting in the right hand lane. Goverdhana advised that yes he was trying to bypass traffic and that he was just really in a hurry. I asked where he was heading, and he stated he was heading to work at the hospital to do his "clinicals". I asked if he was an on-call Doctor and he stated no. I issued Shyam Goverdhana a citation for Shortcutting to Avoid a Traffic Control Device, PMC 432.36 MM. He was given a court date of 1/25/2013 at 0845 hours. Goverdhana was polite and courteous throughout my interaction with him.

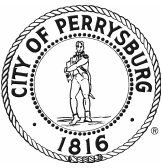

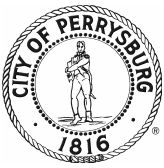
