I estimated the vehicle to be traveling at about 55 mph. The vehicle had merged into the curb lane and was passing a black vehicle on the right. I used laser unit TS006433 to perform a speed check and found the vehicle to be traveling at 55 mph. I initiated a traffic stop and advised the driver, Mr. Nelson, why I had stopped him. 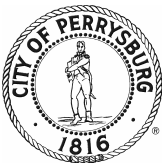
