On listed date/time this unit observed the listed vehicle at Alexis/Telegraph with no headlights on. This unit then activated our over head lights and the vehicle turned north onto Telegraph still with no headlights on. This unit activated our siren and the vehicle continued north on Telegraph straddling the center lane twice. The vehicle then pulled onto Mel Simon and stopped for this unit. Suspect1: Steele, Todd W then exited his vehicle immediately and showed and told these officers he was a Toledo Fireman.
