As the night continued, we had hoped that the behavior was a fluke or a joke amongst friends and we continued enjoying each others company until he made advances toward another female, petted her backside and proceeded to ask/tell her to walk in front of him so that he could evaluate her assets. This was directly in front of our table and in front of my daughter who is a college athlete visiting her brother who attends BGSU on his birthday. Hi Chris

We don't have the entire interaction/exchange between him and the female. While his inebriation was obvious, the video was shot at the end when my wife realized she should probably record it because it had escalated to the point of being overly obvious. As you view the video you can see my daughter approach him to confront him about his behavior. He denied being the coach, but listened to our daughter and responded with an "ok". It wasn't until he called her a "bitch" that my son and I felt the need to intervene. Other coaches stepped in, there was some pushing and yelling but nothing more. To be honest we were shocked to learn earlier in the night that he was the basketball coach because my uncle Joe Tiller was head football coach at Purdue for 14 years and we know the protocol for players and especially coaches. A coach should never be in that situation. Moreover, my daughter being a college volleyball player was really irritated by the events and felt the need to tell him his behavior was not one of a head coach. We are not looking to bring attention too the university but merely to tell you so this never happens again. His arrogance was probably the worst part of the whole situation. We as a family do not want to ruin a persons career or marital situation so we trust you will do what you feel is appropriate without doing that. Hopefully, that can be avoided for his wife and kids sake. Finally, as a family we are a little unnerved by last night, and we don't want to see our kids names dragged into this because they have promising futures and would like to put it behind them.

We have more video of what happened after he called her the name, but we don't think it's really helpful. It's just people cussing and some pushing people away. However if you need it, we can provide it. Again, I would like to reiterate we don't want to ruin lives, and would like you to handle it internally how you see fit. We are normally a private family and this was just an unfortunate series of events.
