POSSIBLE CSC INVESTIGATION

INFORMATION:

I was contacted by Chris Gill from Glass City Investigations in Toledo, OH regarding a possible Criminal Sexual Conduct complaint that he had uncovered. Mr. Gill advised that he was hired by a school board member from the Washington Local School District in Toledo, Ohio to possibly uncover evidence regarding the unethical behavior of Washington Local School District Superintendent Patrick Hickey.

Mr. Gill stated that during his investigation he was able to uncover two possible sexual relationships that Patrick Hickey had with two former female students in the late 1980's and early 1990's. During that time Patrick Hickey was employed as an English Teacher and the Girls Basketball Coach in Addison, Michigan.

PATRICK HICKEY INVESTIGATION:

After looking into the investigation I have learned that there has been a substantial amount of news regarding Mr. Hickey. It appears based on news articles and other information that Mr. Hickey may have been involved in an inappropriate relationship with a staff member while he was the Superintendent at the Washington Local School District in Toledo.

According to the information I obtained Mr. Hickey resigned as the Superintendent of the Washington Local School District on December 11, 2015. The allegations regarding Mr. Hickey's behavior while living and working in Ohio is not being investigated by the Michigan State Police and is only included to show a continued pattern of behavior on his part. It should be noted that the majority of information I have regarding Mr. Hickey's behavior in relation to his employment in Ohio was given to me by Chris Gill and several online news articles.

CRIMINAL SEXUAL CONDUCT ALLEGATIONS/MICHIGAN:

It was found that Patrick Hickey was employed by the Addison School District from approximately 1986 thru 1991. During that period he was Addison High School's English Teacher as well as their Junior Varsity and Varsity Girls Basketball Coach.

It was during this time that Mr. Hickey allegedly was having a sexual relationship with a female by the name of . Mr. Gill stated he had spoke to and she had disclosed to him that she in-fact had a sexual relationship with Patrick Hickey from the time she was 14 until she graduated from Addison High School in

I was further advised that after Hickey's relationship ended with he started a sexual

I asked Mrs. _____ if she attended Addison High School in the late _____ and she said she did. She stated she graduated in _____ I asked Mrs. _____ if she _____ the Addison _____ Team and she stated she did. When asked who _____ was she stated it was Patrick Hickey.

I then read over some of the statements she made to Chris Gill as well as the recorded statement she made to Former Channel 11 News Reporter Jonathan Walsh in regards to Patrick Hickey. I was advised by Mrs. _____ that the allegations of her having a sexual relationship with Patrick Hickey were true. She stated they started having sexual intercourse when she was 14 years old and on the _____ She stated that her relationship with Patrick Hickey continued until she graduated from Addison High School in _____

I advised Mrs. _____ that the relationship she had with Patrick Hickey was in fact against the law and Patrick Hickey could still be charged with a crime. I asked Mrs. _____ if she wanted to pursue charges against Mr. Hickey and she hesitated and then said, "no". Mrs. _____ stated that she is currently happily married and has children. She stated one of her children is currently going to college _____ and she has some concerns about their safety. She stated what happened between her and Patrick Hickey was a long time ago and that even though she knows the relationship was wrong she has suffered no ill effect from it. She stated that as long as Mr. Hickey is no longer having those sorts of relationships with young girls then she does not want to disrupt her life for something that happened so long ago. She did say however if there we other victims then she would gladly come forward and pursue the issue.

I asked Mrs. _____ if Patrick Hickey made contact with her via her Facebook account and she stated he did.

INVESTIGATION OVERVIEW:

Based on the information I received regarding Patrick Hickey's alleged sexual relationships with female
. I find the following:

Patrick Hickey was employed as a teacher and coach for Addison High School in _____ and early
During that time a female student _____ by the name of _____ disclosed
that she was engaged in a sexual relationship with _____ Patrick Hickey. According to documents she
disclosed this information to her mother who then passed the information on to the school authorities.

It was also around this time that another female student _____ by the name of _____ was
allegedly involved in a sexual relationship with Patrick Hickey. There is evidence to support that Hickey did
engage in an inappropriate relationship with _____ however, she never disclosed this to Addison
School Officials as far as I can tell.

After these two allegations were brought to the attention of Addison School Officials Patrick Hickey resigned
as a teacher _____ for Addison Community School's on 11-05-1990. According to the documents I
received there was no public explanation as to why Patrick Hickey resigned. At the time of these allegations it
appears that Addison School Officials including the basketball coach Thomas Britsch, Addison School's
Superintendent Donald Dieck, and possibly members of the Addison School Board of Education failed to
report the allegations to Law Enforcement.

This incident was reported to the Michigan State Police on 02-12-2016 from Chris Gill of Glass City
Investigations in Toledo, Ohio. It was through an investigation by the Washington Local School Board of
Education in Toledo, Ohio and Glass City Investigations that the allegations regarding Patrick Hickey's
alleged sexual relationships in Addison were uncovered. That information uncovered two possible sexual
assault victims _____ and _____

After receiving the information from Chris Gill, I made contact with both _____ and _____
_____ in an attempt to substantiate the allegations that Patrick Hickey had a sexual relationship
with them when they were both under age and students at Addison High School. _____ did
disclose to me that she did have a sexual relationship with Patrick Hickey. She stated it started when she was
14 years old and lasted until she graduated. She stated during that time Patrick Hickey was her teacher and
stated because of all the years that have passed since the relationship happened she no

Interview Summary of Jonathan Walsh

Walsh was interviewed on 11-29-2015 by Chris Gill. Walsh stated he is a former Channel 11 News Reporter. Walsh disclosed that he received information back in 2006-2007 that listed suspect Patrick Hickey had been "sleeping" with _____ at Addison High School in Addison, Michigan. Walsh stated he traveled to Addison High School and found out that Hickey had resigned from Addison High School on 11-05-1990 for allegedly having inappropriate sexual relationships with girls from the high school _____

In Walsh's statement he stated that he was able to make contact with _____ who stated she had a sexual relationship with Hickey when she was a student _____ for Addison High School. She stated they they had sexual intercourse in the equipment room of the High School and also in the North Adams Cemetery. According to the statement _____ also stated she and Hickey had sexual intercourse in Hickey's home.

Interview Summary of _____ - _____ of _____

According to the information contained in the interview with _____ he stated he knew something was not right with _____ and Mr. Hickey. _____ stated he brought it up to his mother who confronted _____ about the relationship. According to the document _____ disclosed to her mother about the sexual relationship she was having with Mr. Hickey. _____ stated that his mother then made contact with Addison Basketball Coach Thomas Brisch. Brisch allegedly spoke to Addison School's Superintendent Donald Dieck and Hickey resigned a short time later.

Interview Summary of Thomas Britsch - _____

According to the information contained in the interview summary Britsch stated he had been informed of some inappropriate behavior between Mr. Hickey and some female _____. Britsch stated when he was informed he took the information to the Addison School Board. Britsch would not elaborate on the accusations or where he received the information. He stated based on the allegations Hickey resigned from _____

She stated she felt that Hickey was overly friendly with the girls and he had an outgoing interest in her best friend at the time [redacted]. [redacted] stated [redacted] never did anything with him though. [redacted] stated one time both her and her mother followed Hickey and a girl by the name of [redacted] to the North Adams Cemetery. She stated that Hickey and [redacted] then both go into the same vehicle and a short time later the vehicle began to start rocking up and down. [redacted] stated her mother turned on the headlights and both Hickey and [redacted] got into their separate cars and sped away. [redacted] then stated her mother gave the information to the Addison School Board and a short time later Hickey resigned.
